

Notice of Elections to be Held and Filing Deadlines

Primary Election - May 14, 2024

General Election - November 5, 2024

Filing Deadlines: February 15, 2024 at 5:00 o'clock PM for incumbents (office holders) and March 1, 2024 at 5:00 o'clock PM for non-incumbents (new filers).

An incumbent is anyone serving in an elective office, even if they are filing for an office other than the one in which they are presently serving.
