A meeting of the Board of Commissioners of Stanton County, Nebraska was held in the open and public session on June 17, 2024, at 8:15 AM in the County Commissioner's room in Stanton, Nebraska.

Present upon roll call were Douglas Huttmann, Dennis Kment and Duane Rehak, Board of Commissioners. Wanda Heermann, County Clerk was also present.

Advance notice of the meeting was given by publication in the Stanton Register on June 5, 2024, a copy of the proof of publication being attached to these minutes.

Notice of the meeting was given in advance to the Board members, a copy of their acknowledgement of the receipt of notice and the agenda being attached to these minutes.

All proceedings hereinafter shown were taken while the convened meeting was open to the attendance of the public.

Following the Pledge of Allegiance to the flag of the United States of America the meeting was called to order at 8:20 AM by Chairman Kment, who announced that the open meetings act is posted on the wall in the Commissioner's room and a copy may be obtained from the County Clerk's office upon request.

Motion made by Huttmann, seconded by Rehak to approve the agenda. Voting: Ayes: Huttmann, Rehak and Kment. Nayes: None.

Motion Carried.

Motion made by Huttmann, seconded by Rehak to approve the minutes of the May 20, 2024, meeting. Voting: Ayes: Huttmann, Rehak and Kment. Nayes: None. Motion Carried.

The following correspondence was reviewed and placed on file: Craig Nelson, NIRMA Director – 2024-25 Billing Statement; Absolute Noise Control information.

Mike Lance appeared before the board to request reimbursement for damage to a fence post damaged during the removal of a tree by the road department. Discussion held on the site and work performed. It was the consensus of the board to submit a claim for reimbursement in the amount of \$91.29.

Discussion was held on an email received from the National Opioid Settlements Implementation Administrator in reference to the new National Opioid Settlement reached with Kroger. Nebraska has elected to participate in the Kroger Settlement which will allow Stanton County to participate. Stanton County must "opt in" to participate in the new settlement prior to the August 12, 2024 deadline.

Motion made by Huttmann, seconded by Rehak to participate in the Kroger settlement and authorize the County Clerk to sign the necessary paperwork needed. Voting: Ayes: Huttmann, Rehak and Kment. Nayes: None. Motion Carried.

Amber presented a contract for appraisal services between the Stanton County Assessor and Central Plains Valuation LLC. Amber explained the contract was for the maintenance program for referee work for protested values. The contractor shall begin the work when agreed to by the County and the Contractor. The contractor shall complete its performance on or before July 25, 2024.

Motion made by Rehak, seconded by Huttmann to approve and authorize the chairman to sign the Central Plains Valuation LLC contract for the maintenance program as referee work for protested values. Voting: Ayes: Rehak, Huttmann and Kment. Nayes: None. Motion Carried. [copy of Contract for Property Appraisal on file in County Clerk's office].

W. Bert Lammli, county attorney, joined the meeting.

Ryan Wehrle, custodian/maintenance, appeared before the board to discuss a water treatment program to prevent corrosion/scale inhibitors in the new boiler/chiller system recently installed. Ryan presented information received from Advanced Water Company Inc (AWC) of Elkhorn Nebraska. AWC would recommend treatment of the system with a closed loop corrosion inhibitor to protect mild steel components, borate buffers to raise pH up into limits to protect system and yellow metal inhibitors to protect sensitive components like brass and copper. AWC will provide testing to ensure chemical residuals are brought up to recommended limits to prevent corrosion and protect system piping and components. Once treatment is complete a routine testing plan will need to be established. The consensus of the county board was to proceed with the recommended treatment system program for the new boiler/chiller system in the approximate cost of \$1,200.00.

Discussion was held on the front entrance walkway handrails. The board had previously requested Ryan to obtain a quote for the extension of the handrails to the parking lot. Ryan presented a quote obtained from Dan Haig in the approximate cost of \$4,500.00 for parts and labor. Discussion was held on the design and costs. Ryan advised the board he would contact Dan about the costs of revisions to his quote.

Kylee Klug, Planning and Zoning Administrator, joined the meeting.

Kylee presented documentation to vacate the Replat of Lot 2 of Alvin Bauer's Lot Split located in Pt NE NW 4-24-1. The reason to vacate the Replat of Lot 2 of Alvin Bauer's Lot Split is to allow a new lot split to be approved.

Motion made by Huttmann, seconded by Rehak to vacate the Replat of Lot 2 of Alvin Bauer's Lot Split located in Pt NE NW 4-24-1, as per Planning Commission recommendations. Voting: Ayes: Huttmann, Rehak and Kment. Nayes: None. Motion Carried.

Kylee presented the Weiland's Lot Split splitting property located in Pt NE NW 4-24-1 into 2 lots. No one appeared for the lot split. Kylee explained the lot split.

Motion made by Rehak, seconded by Kment to approve the Weiland's Lot Split splitting property located in Pt NE NW 4-24-1, as per Planning Commission recommendations. Voting: Ayes: Rehak, Kment and Huttmann. Nayes: None. Motion Carried.

Kylee presented the Asche Lot Split splitting property located in Pt NW NW 36-21-1 into 2 lots. No one appeared for the lot split. Kylee explained the lot split and made reference to the access easement and well easement already in place.

Motion made by Rehak, seconded by Kment to approve the Asche Lot Split splitting property located in Pt NW NW 36-21-1, as per Planning Commission recommendations. Voting: Ayes: Rehak, Kment and Huttmann. Nayes: None. Motion Carried.

Mark Mainelli, Highway Superintendent, joined the meeting.

At 10:15 AM the board members and interested parties left the meeting room to survey the courthouse front entrance walkway. The board had requested Ryan to obtain a quote for the extension of the handrails to the parking lot. A discussion was held with Ryan and Dan Haig on the design and quote presented earlier. The consensus of the board is to proceed with the extension of the handrails on the front entrance walkway in the approximate cost of \$4,500.00. At 10:25 AM the board members and interested parties returned to the meeting.

Shane Weidner joined the meeting to discuss lighting on Industrial Road near Nucor Steel and Benjamin Ave/Old Hwy 35. It was proposed to install 6 lights at the approximate cost of \$90,000.00 which would be paid equally (1/3 each) by Nucor Steel, Madison County and Stanton County. The annual electricity maintenance in the approximate cost of \$1,000.00 would be paid equally (1/2 each) by Madison County and Stanton County. Discussion was held with Mark Mainelli and Shane Weidner on the location of the lights and costs.

Motion made by Huttmann, seconded by Rehak to approve the proposed cost of the installation of lighting near Nucor Steel to be paid by Stanton County in the amount of \$30,000.00 and approve the annual electricity maintenance in the amount of \$500.00. Voting: Ayes: Huttmann, Rehak and Kment. Nayes: None. Motion Carried.

Mark reviewed the Resolution of Completion and Reimbursement Cost Breakdown documents received from Nebraska Department of Transportation on the CBMP(5) Stanton County C008424420 project with the county board. The final cost of Project No.: STWD-CBMP(5), Project Location: C008424420, Agreement No.: BL2118 was \$494,128.40. Stanton County will be reimbursed \$200,000.00.

Motion made by Rehak, seconded by Huttmann to approve and sign the Reimbursement for County Bridge Match and the Resolution Certifying Property Completion of Project STWD-CBMP(5) Resolution No. 2024.06-7. Voting: Ayes: Rehak, Huttmann and Kment. Nayes: None. Motion Carried.

Darrell Hansen, bridge foreman, joined the meeting.

Bid letting was held at 10:30 AM on the Stanton County FEMA Bank Stabilizations – Site 18 and 22, located along the Elkhorn River on 837 Road between 567/568 Ave and at the intersection of 569 Ave and 837 Rd.
