It was noted that an access road had been established after the vacation of part of Road 31 in 2019 to the Pohlman property and Mr. Scholting advised the county board he purchased a road access to his property.

Motion made by Huttmann, seconded by Oertwich to recess the Board of Commissioners meeting at 10:40 AM to open the Board of Equalization meeting to continue with the Protest Hearing decisions. Voting: Ayes: Huttmann, Oertwich and Kment. Nayes: None. Motion Carried.

The chairman reconvened the Board of Commissioners meeting at 12:50 PM.

The chairman reconvened the Board of Commissioners meeting on July 22, 2025 at 2:15 PM which was held in an open and public session in the County Commissioner's room in Stanton, Nebraska.

Present upon the roll call were Douglas Huttmann, Dennis Kment and Douglas Oertwich, Board of Equalization. Wanda Heermann, County Clerk, was also present.

The county board received a thank you from the Pilger Public Library and the Stanton Public Library for the continued support of the county and are requesting funding for the 2025-2026 fiscal year. The consensus of the county board is to continue the \$5,000.00 allotment to the Pilger Library and the \$5,000.00 allotment to the Stanton Library for the fiscal year 2025-2026.

Discussion was held on the hourly and salary wage of the appointed officials and employees. The consensus of the county board is to increase the planning zoning administrator to \$30 per hour, the custodian/maintenance to \$26 per hour, the road department employees to \$25 per hour (non CDL employees \$24 per hour), the bridge foreman to \$27 per hour and increase the annual salary for the emergency manager to \$70,020 effective July 1, 2025. No increase to the VSO hourly wage or the weed superintendent salary at this time.

Further discussion was held on the CDL course available at NECC for road employees. The county board discussed the costs associated with the course, employee time off to attend, and reimbursement for tuition and other costs. An agreement will be drafted for reimbursement to the county by the employee for tuition and any fees/costs.
