Following the Pledge of Allegiance to the flag of the United States of America the meeting was called to order at 8:15 AM by Chairman Kment, who announced that the open meetings act is posted on the wall in the Commissioner's room and a copy may be obtained from the County Clerk's office upon request.

Motion made by Oertwich, seconded by Huttmann to approve the agenda. Voting: Ayes: Oertwich, Huttmann and Kment. Nayes: None. Motion Carried.

Motion made by Huttmann, seconded by Oertwich to approve the minutes of the August 18, 2025, meeting. Voting: Ayes: Huttmann, Oertwich and Kment. Nayes: None. Motion Carried.

The following correspondence was reviewed and placed on file: Village of Pilger – Ordinance #2025-04 establish waste rates, Belz Cemetery letter, NIRMA – NIRMA Annual Member Meeting and Election of NIRMA Board Members, Center for Rural Affairs – renewable energy development.

Mike Unger, county sheriff, joined the meeting and updated the county board on recent events within the county and other department issues. No action needed by the county board.

Motion made by Oertwich, seconded by Kment to recess the Board of Commissioners Meeting to open the Budget Hearing scheduled at 9:00 AM. Voting: Ayes: Oertwich, Kment and Huttmann. Nayes: None. Motion Carried.

The 2025-2026 Budget Hearing for Stanton County, Nebraska was held in the open and public session on September 15, 2025, at 9:00 AM in the County Commissioner's room in Stanton, Nebraska.

Notice of the budget hearing was published in the Stanton Register on September 3, 2025.

Board members present at the hearing were: Douglas Huttmann, Dennis Kment and Douglas Oertwich. No members of the public appeared for the hearing.

The Budget Hearing was opened at 9:00 AM by Chairman Kment for the purpose of hearing support, opposition, criticism, suggestions or observations of taxpayers relating to the proposed budget.

Wanda Heermann, county clerk, made a presentation outlining the key provisions of the proposed budget statement, including, but not limited to, a comparison with the prior year's budget. No change was made to the necessary cash reserves (\$1,300,000.00 General Fund/\$1,200,000.00 Road Fund). To offset operating expenses, \$600,000.00 will be transferred from the Inheritance Tax Fund to the General Fund. The transfer of funds will be accomplished through the claims process. The total tax request requirement for 2025-2026 is \$5,689,860.94 which is an increase of \$219,295.75 from the prior 2024-2025 tax requirement of \$5,470,565.19. Discussion was held on the proposed budget and other budgetary issues.

Motion made by Huttmann, seconded by Oertwich to close the Budget Hearing at 9:25 AM. Voting: Ayes: Huttmann, Oertwich and Kment. Nayes: None. Motion Carried.

The Special Hearing to Set Final Tax Request was opened at 9:25 AM by Chairman Kment for the purpose of hearing support, opposition, criticism, suggestions or observation of taxpayers relating to setting the final tax request.

Board members present at the hearing were: Douglas Huttmann, Dennis Kment and Douglas Oertwich. No members of the public appeared for the hearing.

Discussion was held on the tax request for 2025-2026 budget year. The 2025 certified valuation of Stanton County is \$2,399,251,621.00, which is an increase of \$373,041,262.00 from last year's valuation. The proposed tax levy request is 0.237152, a decrease of 0.032838 per \$100 of assessed value.

Motion made by Huttmann, seconded by Oertwich to close the Special Hearing to Set Final Tax Request at 9:35 AM. Voting: Ayes: Huttmann, Oertwich and Kment. Nayes: None. Motion Carried.

The approval and adoption of the 2025-2026 budget will be held at a Special Meeting set for September 22, 2025, at 8:00 AM in the County Commissioner's Room.

Motion made by Oertwich, seconded by Huttmann to adjourn the budget hearing. Voting: Ayes: Oertwich, Huttmann and Kment. Nayes: None. Motion Carried.

The Chairman re-opened the Board of Commissioner's meeting at 9:35 AM.

Judd Allen, NACO BCBS representative, joined the meeting. General discussion was held on healthcare, insurance renewal and premium rates.

A discussion was held on the Point-C HRS agreements. Documents still need to be reviewed before approval.

Ramsy Robertson, representative of Mainelli Wagner Assoc, joined the meeting. Ramsy updated the county board on various bridge and culvert projects within the county.

Discussion was held on possible purchase of a motor grader/maintainer. Bid Letting set for October 20, 2025, at 10:00 AM.

Mike Frohberg, emergency manager, joined the meeting.

Mike reviewed the 2025 Lower Elkhorn Natural Resources District Hazard Mitigation Plan for Stanton County with the county board. To be eligible for future mitigation funding FEMA requires that jurisdictions formally adopt the Hazard Mitigation Plan (HMP) renewable every 5 years by September 15, 2025.

Motion made by Oertwich, seconded by Huttmann to approve Resolution No. 2025.09-19 adopting the Local Hazard Mitigation Plan update prepared by the Lower Elkhorn Natural Resources District and Lewis and Clark Natural Resources District. Mike informed the county board that he was requested to assist/help at the Missouri River Expo again this year. Discussion was held on NEMA reform changes to public assistance, response and recovery and other changes. Mike advised the county board about future rescue/response exercises in September and October.
