

NOTICE TO BIDDERS

Sealed bids will be received by the Stanton County Clerk until February 17, 2026, at 10:30 a.m. for the construction of a bridge abutment repair and other related incidental work. Bids will be opened at 10:30 a.m. on February 17, 2026, and presented to the Board of Commissioners for consideration. The project is located on 566th Ave between 843rd Road and 844th Road in Stanton County, Nebraska.

The project is referred to as “Stanton North, C008401720 Abutment Repair” and shall include all labor, materials, transportation, and equipment required for the construction of bridge abutment repair and other related incidental work.

Copies of the Bid Documents and Specifications are open to public inspection at the office of the Stanton Clerk, 804 Ivy St., PO Box 347, Stanton, Nebraska 68779. A digital set of bid documents may be obtained from Mainelli Wagner & Associates, Inc. for a non-refundable fee of \$15.00. An optional half-sized paper set of the bid documents is available for a non-refundable fee of \$30.00 (6920 Van Dorn Street, Lincoln, Nebraska 68506; PH: 402-421-1717). All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Stanton County, Stanton County Courthouse, 804 Ivy St., PO Box 347, Stanton, NE 68779, and should be plainly marked as, “Construction Bid Proposal – Stanton North, C008401720 Abutment Repair”.

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Stanton County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to include a Start of Construction and End of Construction date with their Bid Proposal. The desired completion date is September 30th, 2026. The successful bidder (i.e., Contractor) will be allowed Twenty-One (21) calendar days for completion after beginning work, provided they do not exceed their specified completion date. The completion date will be the earlier of the date indicated in the bid proposal or the actual start date plus the allotted calendar days

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Stanton County Board of Commissioners.

The Stanton County Board of Commissioners reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act’s competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114. Stanton County is an Equal Opportunity Employer.
