Notice is hereby given that on Tuesday, November 8, 2022, in Stanton County, Nebraska an election will be held. Said election will be for electing candidates to various offices. All offices are four year terms unless otherwise noted. Some races or issues may not appear on your ballot because candidates and issues are elected by specific subdivisions, districts or wards. Stanton County has been designated as an Election by Mail County by the Nebraska Secretary of State's Election Division. No poll site will be available for casting votes in all Stanton County precincts. Ballots will be automatically mailed to all registered voters and need to be returned to the Stanton County Clerk's office on or before November 8, 2022 by 8:00 PM.
